To explicate the accelerated rural-urban migration in the face of rising urban unemployment, this model postulates that the migration decision is primarily an economic one and that it acts in response to difference in expected earning between rural. and urban areas (Harris and Todaro 1970). In other words, this model shows off that rural - urban migration will be continued. as long as expected wate rate in the other sector is greater than the wage rate in the runal sector, i.e., Wield Bit, Wir.
