While welcoming the said note and future road map/vision set out therein in respect of upgradation of those two colleges, it was resolved that the status report as prepared be sent to the State Government with the request that:

1. Necessary Government Order be issued immediately for compliance of the judgement of the Hon'ble High Court in the matter of the non-teaching employees of the Raiganj College (University College). However while issuing such order, the Government must clearly state the fitment policy into university scale, designation, service conditions, retirement benefits, seniority, date of effect and availability of required fund to facilitate smooth implementation of the order.
2. Similar order may also be issued in the matter of non-teaching employees of the University B.T. & Evening College, Cooch Behar to maintain parity.

It was further resolved that status quo be maintained in respect of teachers of those two colleges until a decision is arrived at by the University and/or the State Government in respect of the future status of those two colleges.

Further resolved that all the cases of claim for appointment on compassionate ground be initially processed and placed by the Office of the Registrar along with the admissibility report to the Establishment Committee constituted by the Executive Council in its meeting dated 05.09.2008 for examination and recommendation to the Executive Council for final decision. However, in order to avoid hardship and to provide immediate relief to the family, the eligible applicant being next of kin may be engaged in the University on "daily wage basis" in a suitable non-teaching position on fulfillment of minimum criteria of that position in the category of Group-C or Group-D staff.

Further resolved that in the light of above decision, Sri Niru Oraon be directed to appear before the Medical Board for examination and if found permanently incapacitated to perform his duties and function by the Medical Board, he may retire from service making next of his kin eligible for appointment on compassionate ground subject to procedure laid down in this respect and the next of kin of late Lagna Basfore be requested to apply in the prescribed form for appointment on compassionate ground and the same be processed and placed in the next meeting of the Executive Council as per procedure laid down herein above. In this connection, it is also resolved that all the pending cases be also processed in the similar way as that of late Lagna Basfore.

Further resolved that a Draft rule be framed and placed before the Executive Council incorporating the entire policy and procedure in respect of appointment on compassionate ground adopted in the 146th meeting of the Executive Council dated 20.12.1999 and those resolved in this meeting for better understanding, transparency and guidance.
