Agenda : To take a decision regarding insecure situation, vandalism, closing of gates, abusing and manhandling of non-teaching employees created by students of various semesters of P.G. Departments of the University of North Bengal since 29.07.2010.

Decision : In view of prevailing unruly and stubborn attitude of a section of P.G. Students demanding publication of results of MA/M.Sc./M.Com, as well as issuance of Provisional Certificates on today itself i.e. 03.08.2010 and their action to destabilize the University system by resorting to vandalism, breakage of University property, manhandling the University employees, teachers, officers restraining them from discharging their duties, using abusive and filthy languages against the Vice-Chancellor, Teachers, Officers and Non-teaching employees including lady employees of this University since 29th July, 2010, and also in view of their refusal to understand the situation and to come reason with the difficulties to publish the result in such a short span of time when the last examination was held on 29th July, 2010 and towards bringing peace and harmony in the campus and law and order under control, Dean, Faculty Council for P.G. Studies in Science, Dean, Faculty Council for P.G. Studies in Arts, Commerce & Law and some members of the Executive Council resolved that (i) special security arrangement for protection of Administrative Building be made forthwith (ii) Police posting in and around Administrative Building be done in general and Controller of Examinations Branch in particular forthwith (iii) Police patrolling be done regularly and frequently at night (iv) Police posting be also provided w.e.f. 03.08.2010 onward in front of P.G. Hostels (v) Police be requested to maintain law and order situation in the campus and to take appropriate measures as may be necessary.
