1. To consider the minutes of the 255<sup>th</sup> meeting of the Executive Council held on 26.03.2010.

Studies in Arts, Commerce & Law is not considered as the Agenda No. 2 along with its decision of the 254<sup>th</sup> meeting of the Executive Council held on 8.3.10, was confirmed in the meeting itself and by the Chair on 8.3.10 and also in the 255<sup>th</sup> meeting of the Executive Council held on 26.3.10 as Agenda No. 1.

- v. Dr. Debi Prasad Boot has approved the action taken by the Hon'ble Vice-Chancellor on 30.3.10 under 10(6) of the NBU Act, 1981 regarding suspension of Dr. Dilip Kumar Sarkar, Registrar.
- vi. Dr. Jyotish Ch. Basak has approved the action taken by the Hon'ble Vice-Chancellor on 30.3.10 under 10(6) of the NBU Act, 1981 regarding suspension of Dr. Dilip Kumar Sarkar, Registrar.
- vii. Prof. Ajit Kr. Roy expressed that as he has not been provided the order of the Single Bench and Division Bench of the Calcutta High Court dated 13.5.10 & 20.5.10 respectively, he refrained from giving any opinion on the Agenda No. 3.

- x. Prof. Ananda Mukhapadhyay, Dean, Faculty Council for P.G. Studies in Science abstained from giving his opinion on the Agenda No. 3.
- xi. Prof. Sekh Rahim Mondal abstained from putting his opinion on the Agenda No. 3 as the matter is subjudice.
- xii. Sri Swaraj Ghosh told that he has no comments to offer on the Agenda No. 3.



- xiii. Prof. Jeta Sankrityayana, Dean, Faculty Council for P.G. Studies in Arts, Commerce & Law left the meeting with the permission of the Chair on health ground before commencement of the discussion on the Agenda No. 2.

Resolved that in view of the fact that highest number of members (four) of the Executive Council did not approve the action for placing Dr. Dilip Kumar Sarkar, Registrar and the then Controller of Examinations, University of North Bengal under suspension vide order no. - i. Misuse of powers by mispending and misappropriating a huge amount of money of University fund out of the Bank Account No. 10195737296 maintained with State bank of India, NBU Campus Branch in the name and style 'Controller of Examinations, NBU' during the period of Dr. Dilip Kumar Sarkar's holding office of Controller of Examinations of University of North Bengal from 01.07.2000 to 26.11.2007.
  - ii. For deliberate violation of the order of Vice-Chancellor dated 9.11.2001 directing internal audit of expenses out of the said confidential bank account in a confidential manner and by such act tantamount to insubordination or disregard or violation of the orders of the Superior Officer from the post of Dr. Dilip Kumar Sarkar,
  - iii. Causing wrongful loss to the University fund of University of North Bengal during 01.07.2000 to 26.11.2007 and which involves criminal breach of trust as public servant and criminal conspiracy with others for allegedly committing grievous misconduct relatable to the findings of report dated 31.03.2008 from Dr. S.N. Saha, Audit and Accounts Officer, University of North Bengal forwarded by the Finance Officer, University of North Bengal, report of Mitra, Roy & Datta dated 12.02.2009 and report of Mr. Arun Kumar Das, ICAS (Retired) dated 07.11.2009;
  - iv. Acts/Conducts of Dr. Dilip Kumar Sarkar tantamount to neglect of duty, ill motive, want of due diligence in the performance of duties and sufficient proof to justify the charge of corrupt practice.

**Decision:** The Executive Council resolved as follows:-

- i. Disciplinary proceedings be initiated against Dr. Dilip Kumar Sarkar, Registrar for (a) neglect of duty (b) want of due diligence in the performance of duties (c) insubordination or disregard or violation of the order of the Superior Officers and (d) misuse of powers.



- ii. A charge sheet be framed and issued to Dr. Dilip Kumar Sarkar, Registrar and to take all subsequent necessary actions as per Rules.
- iii. All subsequent further actions be left to the Vice-Chancellor.
- iv. To report if any other concerned officials are involved in the above type of lapses as mentioned in sl.no. (i).
- v. The Vice-Chancellor be requested to report all the subsequent actions to the Executive Council.
- vi. The Inquiry Report after completion of the inquiry be placed before the Executive Council for further consideration.

Note: Dr. Subrata Sanyal and Dr. Aniruddha Saha refrained from the above decision.


