As directed by the Hon'ble Justice Dipankar Dutta of Hon'ble Calcutta High Court. Hon'ble Vice-Chancellor of North Bengal University placed the preliminary enquiry report submitted by the Enquiry Officer, Mr. Gour Krishna Pattanayak, the Finance Officer of Jadavpur University before the Executive Council in its 24<sup>th</sup> meeting dated 08.01.2015 under Agenda No. 22.

After a considerable discussion on the report, the EC observed that the report ignored the terms of reference of the enquiry, intimated to the Enquiry Officer by a letter issued by the Registrar (Officiating) [Letter dated 08.09.2014, Ref. No. 3779(A)/R-14].

The EC found that the report did not specifically address the issue "whether there are prima facie materials to proceed against "the petitioner departmentally or not". The report also failed to shed light on the charges framed earlier against Dr. Debasis Dutta, which the report was expected to do as per the terms of reference intimated to the Enquiry Officer. Besides, there are several inconsistencies in the report.

**Decision:** In view of the above, the Executive Council unanimously resolved that the preliminary enquiry report prepared by the Enquiry Officer is not to be accepted. It was further resolved that a fresh enquiry regarding this matter should be initiated and completed expeditiously.

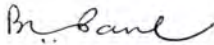

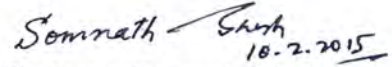

The 37 new entry forms 08 course change forms and 01 subject change form may be accepted. It is also further resolved that from the next academic session no such faulty case of registration will be entertained. A registration committee be formed for the next academic session. The formation of the Committee be left to the Hon'ble Vice-Chancellor.
