As directed by the Hon'ble Vice-Chancellor, his resignation letter along with a backup note initiated by the Registrar (Offg.) was placed in the meeting of the Executive Council.

The Executive Council in its 30th meeting held on 15.10.15 under item no. 17 discussed the matter at length and took the following decision.

Decision: The Executive Council while accepting Dr. Rahul Majumdar's resignation, noted the following points which shall be inserted in his service book.

1. Dr. Rahul Majumdar did not route his application for the above mentioned position through proper channel.
2. Dr. Majumdar did not apply and did not obtain a No Objection Certificate from the University.
3. Dr. Majumdar did not seek any prior permission for the aforesaid position and also to appear in the interview.

The Executive Council noted that Dr. Majumdar has willfully and unhesitatingly and intentionally violated all these stipulated norms and regulations of the University. This is more serious as he himself being in the helm of university administration flouted these norms unabashedly.

In order to prevent such blatant flouting of stipulated norms in future, the Executive Council reiterates that such case of indiscipline and dereliction should be dealt with as strictly as possible. Hence, these points are recorded in the service book of Dr. Majumdar.

The Executive Council also took a decision as not to transmit/transfer the service book of Dr. Rahul Majumdar either to Kazi Nazrul University, Asansol or to any other possible future employer. Dr. Rahul Majumdar will also not have any claim towards any service benefit whatsoever from this university excepting his own contribution to the Provident Fund (PF) account.


