A letter under Ref. No. nil, dated 8th April 2016 was received by the Vice-Chancellor, NBU from the Information and Library Network Centre (INFLIBNET), forwarding a complaint regarding plagiarism in the Ph.D. thesis submitted by Sri Partha Chattopadhyay, under the supervision of Prof. Anil

Bhuimali, NBU and Prof. Bipul Malakar, JU (Co-supervisor). Mr. Partha Chattopadhyay was awarded Ph. D. degree in the year 2015 by the University of North Bengal on the basis of his thesis entitled "Transforming Indian Economy to knowledge Economy: the role of human resources with reference to India". After receiving the complaint of plagiarism, the Vice-Chancellor of NBU immediately forwarded the complaint to Prof. Anil Bhuimali (Supervisor) and Prof. Bipul Malakar (Co-supervisor) for their opinion on the prima-facie validity of the complaints in this regard. In response, both of them were of the opinion that the allegation of plagiarism was not true and there was no such evidence as alleged.

In pursuance of the provisions of the Clause -19 of the NBU Ordinances relating to Ph.D., an Expert Committee comprising two members, *viz.* Prof. M. Thangaraj, University of Madras and Prof. Sankar Majumdar, Visva Bharati, was constituted by the Board of Research Studies in Economics of NBU in its meeting held on 23rd May 2016 (under Item no.-1) to look into the complaint of plagiarism in the said Ph.D. thesis of Sri Partha Chattopadhyay. As directed, the Registrar (Officiating) had approached the Experts for their valued opinion in this regard, enclosing the aforesaid letter of INFLIBNET, dated 8th April 2016 and other relevant documents. Both the experts, in their reply, nullified the complaint of plagiarism and clearly stated that there is no sign of plagiarism in the said Ph.D. thesis of Sri Partha Chattopadhyay. It is pertinent to mention that the experts had used the "URKUND" plagiarism checking software tools –widely used across the academic community for such purpose. The reports received from the two experts were placed before the Board of Research Studies in Economics for its consideration, in its meeting held on 27th July 2016 wherein it was resolved that the complaints or allegation of plagiarism in the Ph.D. thesis of Sri Partha Chattopadhyay was totally baseless and untenable.

Now in view of the existence of a large number of vacancies in the category of non-teaching staff, the University for the sake of its smooth functioning, desires to initiate the process of filling-up the posts – as aforesaid along with some other posts which have fallen vacant during the intervening period. It was also reported that processing of the application against the advertisements as stated above was not feasible as at present and could not be carried out and virtually cancelled for administrative reasons. Accordingly, the aforesaid job of processing the application were to be cancelled because – "The University as the employer always reserves the right to cancel or abandon any recruitment process. No applicant has the right to appointment but they have a right to be considered."
