- v. The following paragraph be appended as the second paragraph of the clause 9.14:
  "The synopsis and the thesis in PDF format may be forwarded to the examiner(s) through e-mail if the examiner gives his consent in this respect."

vi. The following line may be introduced in between the line no. 1 and line no. 2 of the Clause 9.15

"the evaluation report duly signed by the examiner(s) in PDF format and forwarded though e-mail shall also be accepted."
