CONDOLENCE

The Chairman read out the condolence messages as appended below:

গত ১৮ই ফেব্রুয়ারী একজন প্রকৃত শিক্ষাবিদ, বিশিষ্ট অধ্যাপক ও অর্থনীতিবিদ অম্লান দত্তের জীবনাবসান হয়েছে। মৃত্যুকালে তাঁর বয়স হয়েছিল ৮৬ বছর। ১৯৪৭ সালে কর্মজীবন শুরু শিক্ষাকতা দিয়েই। পরের বছর থেকে কলকাতা বিশ্ববিদ্যালয়ে অর্থনীতির শিক্ষক, পরে বিশ্ববিদ্যালয়ের সহ - উপাচার্য হন। তিনি উত্তরবঙ্গ বিশ্ববিদ্যালয়ের উপাচার্য ছিলেন ৮।১১।১৯৭৪ থেকে ২০।১১।১৯৭৭ পর্যন্ত ও পরে বিশ্বভারতী বিশ্ববিদ্যালয়ের উপাচার্য হন। অর্থনীতিতে অম্লান দত্তের গভীর প্রজ্ঞা ছিলো। ছাত্র ছাত্রীদের কাছে সহজভাবে বিষয় উত্থাপনেও তাঁর সাবলীল দক্ষতা ছিলো। অর্থনীতিবিদ হলেও সাহিত্যের জগতে ও তাঁর সহজ বিচরণ ছিলো। বিশ্বভারতী অম্লান দত্তকে দেশিকোত্তম উদ্যোগ দিয়েছিলো। ১৯৯৯ সালে তিনি বিদ্যাসাগর পুরস্কার ও পান। অর্থনীতি এবং সমাজ সম্পর্কিত তাঁর বিশিষ্ট চিন্তাভাবনার জন্যই জনপ্রিয় ছিলেন তিনি। শিক্ষা, দারিদ্র দূরীকরণ, মানবোন্নয়ন নিয়ে স্বকীয় ভাবনার কথা বলতেন তিনি।

অম্লান দত্তের প্রতি শ্রদ্ধা জানাতে আমরা ১ মিনিট নীরবতা পালন করছি।

জ্যোতি বসু

ভারতীয় রাজনীতির ও ভারতের কমিউনিস্ট আন্দোলনের জীবন্ত কিংবদন্তী, আমৃত্যু মার্কসবাদে অবিচল কমিউনিস্ট জননেতা জ্যোতি বসু গত ১৭ই জানুয়ারী ২০১০ প্রয়াত হয়েছেন। তাঁর জীবনাবসানের মধ্য দিয়ে শেষ হল ইতিহাসের একটি কাল পর্বের, একটি অধ্যায়ের একটি মুগের।

বিরোধী নেতা হিসেবে যেমন একের পর এক আন্দোলনের নেতৃত্ব দিয়েছেন তেমনই মুখ্যমন্ত্রীর আসনে বসে ভূমি সংস্কার শিল্পায়ন, অপারেশন বর্গা, পঞ্চায়েতিরাজ প্রতিষ্ঠার সমস্ত কৃতিত্বের অধিকারী তিনি। প্রতিটি পদক্ষেপে মানুষের কল্যাণের প্রশ্নটিকে তুলে ধরেছেন তিনি।

তাঁর সমগ্র জীবনটাই একটা সংগ্রাম। পশ্চিমবঙ্গের সাধারণ মানুষের বেঁচে থাকার সংগ্রাম আর জ্যোতিবাবু কোথায় যেন হয়ে গিয়েছে। একে অপরের পরিপূরক। তাঁর প্রয়াণে বাংলার মানুষ হারালো স্বাধীনতার পর তাদের জীবনের সবচেয়ে বড় সংগ্রাম। বাংলা ও বাংলার মানুষের জীবনে এই ক্ষতি অপূরণীয়।

ভারতের কমিউনিস্ট আন্দোলনের আরো এক নক্ষত্র রাম নারায়ণ গোস্বামী, প্রাক্তন স্বাস্থ্য মন্ত্রী গত ৯ই ফেব্রুয়ারী প্রয়াত তিনি সারা ভারত কিষাণ আন্দোলনের একজন অভিজ্ঞ জননেতা ছিলেন। রাম নারায়ণ গোস্বামীর প্রয়াণে আমরা গভীরভাবে শোকাহত। প্রতি শ্রদ্ধা জানাতে আমরা ১ মিনিট নীরবতা পালন করছি।

Decision: The Report of the Audit and Accounts Officer bearing no. 3106/F-08: Con./AAO dated 31.10.08 duly forwarded by the Finance Officer, University of North Bengal dated 31.10.08 Special Audit – cum – Investigation on examination expenses out of Bank Account No. 10195737296 maintained with the State Bank of India, NBU Campus Branch in the name and style, 'Controller of Examinations North Bengal University' and operated solely by the Controller of Examinations for payment to confidential printers during the period from 22.12.1999 to 31.03.2008 was placed for consideration of the Executive Council.

The report on Special Audit – cum – Fact Finding investigation dated 12.2.09 on the same subject furnished by M/S. Proposal 4: Two members opined that if the Proposal 1 is not accepted within the purview of Section 45 & 46 of the NBU Act, 1981, the entire matter be referred to the Hon'ble Chancellor, University of North Bengal for direction.

The Chairman of the Executive Council clarified and opined that as per Section 45 & 46 of the NBU Act, 1981 and Statutes, Ordinances, Rules, Regulations framed there under, there is no provision for sending three reports and legal opinion to the State Government for opinion as proposed in Proposal 1, as the Section 45 of the NBU Act, 1981 relates to Annual Accounts and Audit and Section 46 has empowered the State Government to initiate actions in respect of various issues and subsequent actions to be taken there under.

In view of the four different proposals, which have come up from amongst the members of the Executive Council, University of North Bengal, the Chairman, Executive Council, University of North Bengal has decided to send the three reports i.e. (i) Report of the Audit & Accounts Officer dated 31.10.2010 duly forwarded by the Finance Officer, (ii) Report of Mitra, Ray, & Dutta dated 12.2.2009, (iii) Report of Mr. A.K. 


