ii) The name "Sikkim Law College, Gangtok" be replaced by the name "Sikkim Government Law College, Gangtok."

Resolved that the draft amendments be approved and forwarded to the Chancellor for assent.


Resolved that the recommendation of the Executive Council be approved.


5. To report that Prof. Prabuddhanath Ray has consented to be the Chief Guest at the 33rd Annual Convocation.
