Decision: The members unanimously resolved that the decision of the 22nd Meeting of the NBU Court held on 29.11.2018 be noted, confirmed and approved.


2. To consider the date for holding the 49th Annual Convocation, 2019 of the University as proposed by the Executive Council, NBU.
