### CONDOLENCE

Before commencement of the day's business the members of the Executive Council expressed profound sorrow and observed silence for one minute at the sad demise of Sri Subhas Chakraborty, MIC, Transport, Sports & Youth Service, Govt. of West Bengal. The Chairman read out a condolence message on the life of the demised social leader as appended below:

আমি অত্যন্ত দুঃখের সঙ্গে জানাই যে পশ্চিমবঙ্গ সরকারের পরিবহন, ক্রীড়া ও যুব কল্যান দপ্তরের ভারপ্রাপ্ত মন্ত্রী তথা শ্রমিক আন্দোলন ও ছাত্র আন্দোলনের অন্যতম নেতা মাননীয় সুভাষ চক্রবর্তী গত ৩রা আগস্ট প্রয়াত হয়েছেন। গত শতাব্দীর পঁচের দশকের শেষ ভাগে ছাত্র আন্দোলনের মধ্য দিয়ে তাঁর রাজনৈতিক জীবনের শুরু এবং তিনি ছাত্র সংগঠনের সর্বভারতীয় সাধারণ সম্পাদক হয়ে দায়িত্ব পালন করেছেন। সুভাষ চক্রবর্তী ট্রেড ইউনিয়ন আন্দোলন সংগঠিত করেছিলেন এবং তিনি ছিলেন একজন দক্ষ সংগঠক ও জনগণের নেতা। গর্ন সংগঠন গড়ে তোলায় তাঁর ভূমিকা ছিল অপরিসীম।

সুভাষ চক্রবর্তী ছাত্র, শ্রমিক, কৃষক ও মেহনতী মানুষের স্বার্থের জন্য নিজের সমগ্র জীবন অতিবাহিত করেছেন। সমাজের পিছিয়ে পড়া বঞ্চিত মানুষের জন্য কখনও পরিশ্রম বিমুখ হন নি। শিক্ষার অধিকার এবং সামাজিক অধিকারের জন্য ছাত্র সংগঠিত করার কাজে তাঁর ভূমিকা অনস্বীকার্য।

দেশের ছাত্র, সমাজ, কৃষক এবং শ্রমিক শ্রেণী তাঁকে তাদের স্বার্থের প্রতি নিবেদিত প্রাণ এই জননেতাকে চিরদিন স্মরণ রাখবে। পশ্চিমবঙ্গ তথা সর্বভারতীয় খেলা ধুলার ক্ষেত্রে তিনি ছিলেন একটি প্রতিষ্ঠানের মতো। সরকারের সীমিত বাজেটকে মাথায় রেখে ক্রীড়ামন্ত্রী একটির পর একটি কাজে হাত দিয়ে তা সফল ভাবে শেষ করেছেন। তাঁর ছিল অদম্য উৎসাহ, অফুরন্ত প্রাণশক্তি ও শহর ও গ্রামের মানুষকে উজ্জীবিত করার অসাধারণ গুণ। তাঁর অকাল প্রয়ানে আপামর জনগণের অপূরণীয় ক্ষতি হলো।




