দেশের ছাত্র, সমাজ, কৃষক এবং শ্রমিক শ্রেণী তাঁকে তাদের স্বার্থের প্রতি নিবেদিত প্রাণ এই জননেতাকে চিরদিন স্মরণে রাখবে।






