The above stand of the Executive Council shall lead to a serious lapse on the part of authority of University of North Bengal.

Dr. Susanta Das, Controller of Examinations and member of the Executive Council also placed his note of dissent expressing the following: "The bills should have been passed subject to clearance of the Audit objection by the concerned firm. Otherwise, the University may be in a disadvantageous position, legally and financially, if the payments are not done due to internal irregularities".
